It is understood by me that any infraction of rules governing the safe handling of firearms by me may cause the Club to cancel my membership, and that said membership can be canceled by the Board of Directors of the Santa Maria Gun Club, Inc., for infractions of said rules. It is further understood, that as a condition of membership, I will be expected to donate, if physically able, 12 hours per year for volunteer work. Dues and any other contributions to the Club are not federal tax deductible.
